1---Cathy Jolly, Wayne Cauthen and Mike Sanders will make a major announcement regarding public safety at the start of this week's Public Safety Committee at 10am today on the 10th floor (?);

2---this important announcement is the culmination of efforts that have spanned more than 30 years to consolidate a critical city and county function

3---the details of this consolidation have not been finalized, but it is anticipated to save the City approximately \$1 million a year,

4---other counties in the area will also be involved as final plans for the consolidation progress.
